Taxes remaining unpaid after they have become due shall, in addition to the amount of the unpaid tax, bear interest at the rate of 12% per annum, and the taxpayers upon whom said taxes are imposed shall be liable, in addition thereof, to a penalty of 1/2 % of the amount of the unpaid tax for each month or fraction of month for the first six (6) months of nonpayment, or Five (5) Dollars, WHICHEVER IS THE GREATER.
